
All the students of G.B. Pant Engineering College are required to deposit Annual fee for the Academic Year 2018-19 as per following details.

Student's admitted under PMSS quota are required to deposit the one time security deposit (refundable) of Rs.5000/-. The Students admitted under NRI Quota are required to deposit the annual fee as per existing rules.

The above fee should be deposited in favour of G.B. Pant Engineering College from 20<sup>th</sup> August, 2018 to 14<sup>th</sup> September, 2018 through SBI Collect mode of online payment method only. The photocopy of online transaction slip must be deposited to Academic Department after the successful transaction.

A Late fee of Rs. 2000/- along with the Annual fee shall be charged from 15<sup>th</sup> September, 2018 to 4<sup>th</sup> October, 2018 and an additional late fee shall be charged @Rs.200/- per day from 5<sup>th</sup> October to 17<sup>th</sup> October, 2018. No fee shall be collected after 17<sup>th</sup> October, 2018 and the admission of the student may be cancelled.
